Subject: Implementation of 'Hub & Spoke Model' under Vocational Education Programme in Government Secondary Level Schools of Tripura from the Academic year 2023-24.

In order to expand the coverage of Vocationalisation of Secondary Education in Government schools of Tripura, the Project Approval Board (PAB) 2023-24, Samagra Shiksha, New Delhi has approved implementation of 'Hub & Spoke Model' in existing 16 Vocational Education implemented schools of the State as Hub school and 16 new schools for introduction of the same as Spoke schools of Tripura (list enclosed at Annexure - A) from the year 2023-24.

Accordingly, the State Government in School Education Department has decided to introduce National Skill Qualification Framework (NSQF) compliant Vocational Education Programme in 4-sectors namely; IT/ITES, Electronics & Hardware, Agriculture and Retail in those selected 16 Spoke schools with single sector in each school from the Academic Year 2023-24 under Samagra Shiksha from Class IX onwards.

Further, the students of the spoke schools will utilize the lab facility of the respective Hub Schools while attending practical classes in the Hub schools. Moreover, theory classes for the students of the Spoke schools will be conducted in the respective schools where the Vocational Teacher of Hub School will visit to the spoke school as per the schedule fixed by the respective school authorities.

The Vocational subject will be treated as 6th Subject under the Academic control of Tripura Board of Secondary Education (TBSE) as notified vide its Notification No. F. 29(3)/VOC/EXAM/TBSE/2018/1152-63 dated 04-08-2023 (Annexure-B). The candidates of spoke schools may take the Vocational subject in lieu of any 6th Subjects already existing in the curriculum of TBSE. The process of assessment, accreditation and certification of the Vocational subjects will be monitored and controlled by TBSE.

The curriculum and syllabus for Vocational Education Courses will be followed as per framework designed by **Pandit Sundarlal Sharma Central Institute of Vocational Education** (PSSCIVE), Bhopal, a constitute unit of NCERT, MoE, Govt. of India established for research and development in the field of Vocational Education.

Guidelines for implementation of 'Hub & Spoke Model' under Vocational Education Programme in Government Secondary Level Schools of Tripura from the Academic year 2023-24 under Samagra Shiksha, School Education Department, Govt. of Tripura

In order to reduce drop out at Secondary Level and to prepare educated, employable and competitive human resource for various sectors of the economy and the global market, the State Government in School Education Department has decided to introduce Vocational Education subjects from class IX in selected Government Higher Secondary schools. The main objective of the course is to bridge the gap between the academic and applied learning and reduce the dropout rate in schools.

Further, to expand the coverage of Vocationalisation of Secondary Education in Government schools of Tripura, the concept of Hub & Spoke Model has been introduce in existing 16 Vocational Education implemented schools of the State as Hub school and 16 new schools for introduction of the same as Spoke schools of Tripura from the year 2023-24.

The Vocationalisation of School Education has been aligned with the National Skill Qualification Framework (NSQF) notified by the Ministry of Finance. It has been developed in a way that it links the various elements of Vocational Education in schools with those of the general education, businesses and industry so that the students can pass out with employment-related skills. The Vocational subject of those spoke schools are to be introduced as a 6th Subject at Secondary level as notified by TBSE vide Notification No.F.29(3)/VOC/EXAM/TBSE/2018/1152-63 dated 04-08-2023.

In the State, the scheme would be implemented by Samagra Shiksha under School Education Department, Government of Tripura through its appointed experienced, qualified and resourceful Vocational Training Provider (VTP) while School Authorities of the selected Spoke schools will provide classroom in the concerned schools.

1. Programme Management

The State Government in School Education Department, Govt. of Tripura has decided to award the task of implementation of Hub & Spoke Model under Vocational Education Programme to SIBIN Learning Cart Pvt. Ltd., as a Vocational Training Partner (VTP) of Samagra Shiksha, Tripura during the period from the Academic year 2023-24 to the tenure of ongoing course running by SIBIN in the respective schools. They have been appointed for utilizing their experience and expertise in various domains, like project management, training, setting up of Vocational labs, organizing career fair etc to facilitate Vocational Education in such selected schools of the State.

2. Responsibility of School authority

The school authorities (both Hub & Spoke schools) shall be responsible for providing well secured rooms/adequate space to conduct practical as well as theory classes. Further, the School authorities (Hub & Spoke Schools) shall prepare the class routine in such a way to provide minimum 20 Theory Classes per Quarter (@ minimum 45 minutes per class) i.e 60 hours in an Academic Year and 140 hours practical classes including Hands on Skill training session per year.

3. Deployment of Vocation Teacher (VT) and conducting of classes

In order to carry out the training/ classes/activities under the scheme, VTP would deploy Vocational Teachers/Trainers of respective Hub schools to the concerned Spoke schools. The Head-teacher of each Spoke school would be acting as Chief Coordinator and will ensure full support to Vocational Teacher with seamless coordination for effective & successful implementation of vocational Programme.

4. Awareness, Counselling & Mobilization of students

- a. The students passing class VIII and continuing in class IX in the Spoke schools would be eligible to opt for a vocational subject as one of the 6th Subject. The concerned Head-teachers will encourage and motivate students for taking Vocational Education as 6th Subject.
- b. As per Guideline of MoE, Govt. of India, enrolment limitation in this subject is 40 students in Class IX.
- c. The selected VTP through Vocational Teacher (VT) will make effort to draw and attract students to the respective sector under Vocational Education in the notified schools.

5. Conducting of Guest Lecture sessions

VTP would be required to arrange for visit of Guest Faculty in the Spoke schools as per the terms & conditions agreed with Samagra Shiksha, Tripura. Guest Faculty would be responsible for delivering lectures on industry practices and taking classes aligned with the courses based on job role. The Guest Faculty should be from relevant industry / sectors with adequate work experience / expertise. The Head-teacher/In-charge of the school will ensure full cooperation to VT for conduct of guest lecture session.

6. Industry Visit/Hands on Skill training

- a. VTP would arrange for industry visit for vocational students of the Spoke schools as per the terms & conditions agreed with Samagra Shiksha, Tripura. Students enrolled in vocational course will visit local industry and work sites to experience and understand the work requirements as per the need of the time and make choices of their career accordingly.
- The Vocational Teacher in coordination with Head-teacher of the school will monitor the industry visit.

7. Transportation of students of Spoke schools

While attending practical classes by the students of Spoke schools to the Hub schools, local transportation for those students will be arranged by the respective Spoke schools in support with the District Coordinators. In this regard, there will be an allotment of Rs. 3000/- per Vocational Education enrolled students of the Spoke schools for an Academic year.

8. Other Activities & Responsibilities

- a. The course durations would be as per the durations mentioned in the curriculum developed by PSSCIVE or as may be decided /notified by the State Government. Tripura Board of Secondary Education would issue respective Orders/notifications and guidelines to incorporate the courses in the Public Examination Calendar so as to ensure that the courses run in conformity with the regular class teaching process.
- b. The duration of each class and the timings would be notified by the Head-teachers of the schools. The Head-teachers of the schools would be responsible for in-corporating the Vocational Education classes in the teaching-learning schedule of the schools.
- c. The school administration should arrange for adequate number of Vocational classes to complete the curriculum within the academic timeframe.
- d. VTP would be responsible for providing books, relevant resource etc. to each student enrolled in Vocational Education course for effective implementation of the programme.
- e. The school administration will ensure effective and proper utilization of the lab equipments, relevant resource etc. provided under the programme.
- f. All the reports to be submitted by the Vocational Teachers must be verified/authenticate by the Head-teacher of the respective schools.
- g. The VTP shall have to set up one help desk to provide technical and day to day assistance to the school Head Teachers / Vocational Teachers / School Education Department in terms of implementation of Vocational Education Programme in the schools of the State.
